Now the planning work starts for our next Hunt Test. It will probably turn out even better. Thanks again!


Training Day Report

Formal club training days are tough to schedule in the summer and impossible once the seasons open. Some metro area members have been gathering on Thursday evenings at the public land/water site in Blaine. These events have been placed on the Club Calendar as informal training, starting around 6:30 pm. The site is near the NE intersection of I-35W and 95th Ave.

On Sat. Sept 10 we will hold a Training Day at Elk River Kennels, as this is the weekend before the Grouse Season opens we can use it to test where our training is at going into the time when it really counts. Set up begins at 8:30 am, and the materials cost will be \$5 person.

Discussions among club members at the Hunt Test were about organizing a game farm pheasant hunt as a club activity either before or after the 'busy season'. To make this happen someone will need to step up and take charge, as reservations will be required. Maybe at Game Fair? It could happen.

Remember that during the "nesting season" (into July) there are rules and regulations from the Minnesota DNR that must be followed. Wildlife management is serious business – stay safe and know the rules.



Land Of Lakes HRC Spring Hunt Test Review Notes

Future needs: More equipment, more equipment, more equipment

The analysis from our Spring Hunt is clearly focused that what our club really needs is more equipment and more organization for keeping track of it.

Equipment is the biggest challenge of every HRC club that seeks to conduct quality Hunt Tests and Training Days. For a club that is less than three years old the LLHRC has a fair amount of equipment, but as we discovered at the Hunt we have a long way to go to be a premier event host.

To begin this process we need to start with an understanding of what we have, what we want, what we need, what we can afford, and how we can acquire it within our budget constraints. To start the conversations of this process this article recaps comments, observations, etc, from the Hunt regarding club equipment needs. This list of needs should not be considered set in concrete or complete, but rather a starting point for further discussion. During the course of club meetings, gatherings and events in the coming months hopefully we can put a plan together regarding equipment.

A management method for Hunt Test equipment such as an inventory list and check-out/in system with the site marshals. All of the equipment needs to be assigned to hunt test site (started, seasoned, finished) and painted with where it belongs.

Radios. Good Radios. We suffered because of communication challenges. If the club had five (5) top end Motorola Talk Abouts it would make test site management a much easier task This should be a goal of the club to own these radios as part of its inventory of equipment, at the very least club members should be encouraged to bring these radios to the hunt test and allow the club to use them during the weekend.

Shotguns and poppers. The club should own a minimum of four Remington 870 12 gauge shotguns. These are often available at gun shows for \$100 in decent condition. Once acquired they should be marked with a wood burner with the club name and the level they will be used at. More poppers in inventory for the hunt test is a recommendation, or at the very least a better

control of the inventory we do have on hand and its distribution. Planning should include 15/day/dog finished; 10/day/dog seasoned; 5/day/dog started; 4 boxes for setup friday and test dogs Sat & Sun.

More Buckets. Buckets are vital to the operation, we need buckets with holes and buckets without holes for rebirding needs. Again buckets should be assigned to a site and marked accordingly. A source for inexpensive buckets would be a positive for the club.

Drying Racks. Duck drying racks are a vital component for a successful hunt test. If they are portable so much the better. Suggestion for construction is to have a 2"x4"x8" with nails supported by quick props. Whether or not smaller drying racks at the wingers would be overkill is another thought, but they could make it possible to extend the life of our birds.

Bird Management. Quality birds are important to the success of a hunt test. Nelson Game Farm is a great resource for HRC clubs and every effort was made to make this initial contract/event a positive one for both parties. Birds are also a significant expense item and a significant judge / contestant relations item as well so this component must be managed for maximum effectiveness. This was our first major hunt event and we did manage our birds adequately; we went over budget 14 birds, buying 134 rather than the 120 we guaranteed. Steve Nelson had more on hand because he figured we would need at least 150 as most clubs use 200 for a back to back hunt test. A written plan would make this component easier to manage. Club should own 5 bird crates.

Blinds. Each winger needs a blind, some need two depending upon how the test is setup. More blinds would benefit the club at training days as well. Holding Blinds should be 6'h x10'l with poles and camo netting (need 4), need seven (7) Bird Boy Blinds of approx same size

Decoys. The club should have decoys in its inventory of equipment. A minimum of three dozen duck decoys with weights and one to three dozen goose silhouettes for land.

Covered Trailer for equipment. A covered trailer owned by LLHRC should carry all the equipment.

Equipment manager should be an official club position as well.

Equipment / Site Management. Inventory lists for check out and check in are needed for each test site Accountability is a positive in this effort to get the right equipment to the right place at the right time.

Marking the equipment. Each test site should have dedicated equipment, and the location should be painted right on the equipment. For example; Started Winger One, Winger Two; Started Bucket Two; etc. This would make it much easier to the right stuff to the right place.

Site Marshall's "Bucket:" Each Site Marshall should have a container of stuff to effectively manage their site. This bucket should contain: extra ties; first aid kit for dogs and humans; mosquito dope; red marketing tape; extra rubber for wingers; sledge hammer; duck call, goose call; backup poppers; suntan oil; plastic garbage bags; burlap sacks; dog lead; small garbage can; cooler with ice for bird boys; ten camo buckets; 8 camo swivel seat buckets; toilet paper; baby wipes; 2 rolls of duct tape; spray paint; Hatchet; Machete; Pruners; Long handled mallet; and other stuff. Hunt Marshall should also have a bucket of stuff to back up all of the site marshals.

Minimum Hunt Test Equipment Needs: Eight Wingers; 8 Pouches; 32 hold down stakes for wingers; 32 tie down straps for wingers; a boat or canoe; 3 duck drying racks; 5 bird crates; camera and film; poppers: 15/day/dog/finished, 10/dog/day/seasoned and 5/dog/day/started; basic tools such as hammer, pliers, scissors, stapler, etc; Tarp; Ribbons; Judges Gifts; judges scoring sheets; HRC rule book

Other stuff: Premium Book; Gifts for Judges; Ribbons; Bitch Check tickets; Test Dogs prearranged for each test; confirmation letters to judges; To Do Lists for Gun Steward, Hunt Steward, Site Marshals, Hunt Committee, Canopy/HQ, Should redesign winger pouches and the wingers w/ tripod- louisiana strong arm. Judges stuff includes binders; transportation; dinner; gifts. Raffle needs chair/committee. A welcome to new members. Name tags for those in attendance.

First Annual Judge's Fishing Contest Held At Spring Hunt.

Minnesota is famous for our great fishing lakes and outdoor traditions. LLHRC held a fishing contest for our judges, most of whom were from out of town, at Jim and Sharon Bowden's home on Friday night before the Hunt.

The contest was a winner take all event with a last minute sponsor adding a top prize and the winner could have won a Ranger boat.

With test set-up taking a bit longer than planned, and Sharon's lasagna dinner drawing attention, the contest was shortened though a few fish were caught. As with any judged contest there were some rules that had to be followed. Unfortunately the contestants disqualified and the boat went unclaimed.

There was some call for earlier publishing of the rules (which were passed out prior to the contest) so that next year's Hunt Test Judges know what to expect. Here they are:

Fishing Tournament Rules and Regulations

Contest rules and regulations are designed to make this a fun, fair and equal opportunity event following the Fishing Laws, Rules and Regulations of the Minnesota Department of Natural Resources, the Federal Government and the LLHRG to make this event I shuft Test success for the club. Failure to adhere to the laws, regulations, rules and standards will result in the disqualification of the contestant.

This contest is a "winner take all" event. Entry fee is \$10 per contestant. Winner shall be the one to This context is a "winner take all" event. Entry fee is \$10 per contestant. Winner shall be the one to secessfully each the most fish in the intel allowed; in the case of at its of the most fish caught the winner shall be determined by weight of fish; in the case of it is of number of fish and weight the winner shall be determined by a species caught; if a its still exists the winner shall be determined by a coin toss. In the case of a dispualification the entrant with the next most quantity of fish successfully caught will be considered for winning. All non-winning entrants will receive a consultation prize of a ticket to the LLHRC Special Shotgun Raffle. The decision of the LLHRC Fishing Contest Judge shall be final.

Regulations in effect in follow Minnesota's Euphorian Principles of Coexistence with Our Mother Earth including humane and respectful treatment of your bair and all fish caught, bait cannot be considered as fish caught. Equipment used must not give one contestant an unfair advantage over another; this included the contestant contestant are unfair advantage over another; this included a variable to all consessants; combinations of live bair with food products; or exotio near-antive attractants. Lures must contain an even number of barbed hooks. Use of tournament sponsor marked equipment is mandatory, if there is no tournament sponsor Minnesor's favorite cartonist Charles Schultz's sall fill that role given the wide accessibility of equipment with his mark, not having a Peanuts character on equipment shall be a disqualification. Responsible consumption of beverages is encouraged during the catching of the third fish shall be a disqualification, not consuming a liquid between the catching of fish number four and five could lead to dehydration and shall also be a disqualification. Contestants must have a valid license to participate, since registration and a "cool-off" waiting period has worked so well for gun purchases there shall be an equal 72 hour wait from the purchase of fishing license and the entering of a fishing tournament. Rules are subject to change without notice.

Here's what to expect if you and your dog come to Game Fair to volunteer: In the booth you will be asked to first keep your dog under control and second sign up new members by talking with people who stop by about HRC and LLHRC. Game Fair '99 requires that dogs in the exhibit area be kept in a crate, no tie ups or left free will be allowed, so please bring a crate for your dog. All dogs must also register at the entrance, get a game fair dog number and be up-to-date on their required shots according to age, with at least the first series of puppy shots or a complete series if the puppies are old enough. LLHRC members and dogs should wear hunting attire when in the booth and must wear it when participating in a demonstration. Since the weather is likely to be warm, camo shorts are perfectly fine attire. Bring a duck call. We will demo Started, Seasoned and Finished Hunt Tests. During our demos we will place emphasis on gun safety. At the booth we will have Lana's training table for demonstrations and for something to do, and we'll have a fund raising game of skill with a free local membership as the prize.

Volunteers can park in the Exhibitors Parking lot near the entrance. When arriving at Game Fair drive to the gate, go to the Information Desk where you will pick up an exhibitor badge, register your dog, then you can park and carry in your crate, etc. The event opens for exhibitors at 8:00 am.

To encourage new club memberships at Game Fair will be offering a local dues special of \$10 for '99. All new members must join both the local and national HRC clubs. The national dues are \$20/indiv and \$25/family for 12 months. Local club membership renews in January each year. New members joining at Game Fair will also receive a 10# bag of dog food and a hat. Combining all this stuff with the opportunity to get involved with a great group of hunting dog people I think we should be the best deal at Game Fair!
