The following are the descriptions of the jobs that go into making a HRC Hunt Test work. Hunt Marshall: Wade Samson, Saturday Randy Gustafson, Sunday

The Hunt Marshall is the person in overall charge of the Hunt. The duties are: overall supervision of the Hunt Committee Members and to perform such duties as may need to be performed.

Hunt Secretary: Mark Switzer

The Hunt Secretary is responsible for seeing that the following items are accomplished:

Hunt Packet: (Information from UKC that includes: Official Hunting Retriever Hunt Report; Judges Report; Apprentice Judges Forms; Judges sheets; Points Receipts; Formal Complaint Forms; and various membership and registration forms, UKC & HRC brochures and DNA brochures.) Judges, Judges Notebooks, Point Receipts, Premium, Program, Running Order Assignments, and Registration.

Official Hunt Committee:

Norm Peterson, Mark Ekeroth, Tom Montez, Wade Samson & Randy Gustafson

This committee is usually comprised of the Hunt Marshall and three other persons and are listed on the Hunt Entry Premium. The members of the Official Hunt Committee must be present on the setup day to assist with, review and approve the legality of the Tests that the Judges set up. The Hunt Committee is also responsible for handling any official complaints that might arise during the event and such other duties as may required.

The Marshals are to ensure the smooth running of the Test they are assigned to. Their duties include the following:

- a) Bird Throwers are on site and are knowledgeable as to their specific duties.
- b) All equipment is in place wingers, blinds, gun stands, guns, poppers, refreshments for Judges and Bird throwers, crates, chairs, birds, etc.
- c) Gallery area is assigned and kept quiet when retrievers are running.
- d) Holding Blind areas selected.
- e) Retrievers are ready to run as the Judges call for them.

Bird Throwers Chairperson:

Responsible for securing and coordinating schedule of Bird Throwers for the Hunt.

Bird Throwers:

Started: 2 for each A.M. & P.M. Seasoned: 3 for each A.M. & P.M. Finished: 4 for each A.M. & P.M.

Bird "technicians" throw the birds for the marked retrieves and plant the blinds. Bird technicians are directed by the Judges as to the timing and placement of the marks. They operate the wingers to launch the marks. Full time bird technicians receive \$20, lunch and refreshments.

2001/2002 HRC Rulebook Test Excerpts

Dogs and Handlers competing in HRC Hunt Tests are competing against a written standard rather than against other dogs, as a result many dogs can "win" at the same Hunt. This fact is what sets the Hunting Retriever Club tests apart from field trials. There are many other differences too, such as our handlers are also judged on criteria that involve true-to-life hunting situations such as gun safety and respect for their dogs and fellow hunters.

The rules and standards are printed in the UKC Rules and Guidelines for Hunting Retriever Tests. Available from the United Kennel Club, Inc., 100 East Kilgore Rd., Kalamazoo, MI 49002-5584, (616-343-9020).

Changes were made to the Rulebook that became effective January 1, 2001. In an effort to get the membership thinking about becoming HRC Judges your newsletter editor got his hands on a copy of the new Judge's Test. Starting with this issue will be excerpted questions from the test for your review.

Venison & Mushroom Chili

1 ounce dried mushrooms, broken into small pieces

1/2 cup bourbon

3 Tbs. vegetable oil

2 medium shallots, finely chopped

1 medium garlic clove, finely chopped

1/2 fresh red serrano chile, finely chopped

1-1/2 Lbs. ground venison

1/4 cup medium-hot pure chile powder

1 Tbs. ground cumin

2 bottles (12-oz.) dark beer

1 (14-1/2 oz) can crushed tomatoes

1 Tbs. salt (omit if you use regular chili powder)

1 tsp. fresh ground black pepper

1 tsp. dried leaf oregano

1 tsp. dried leaf basil

1 tsp. dried leaf thyme

3 Tbs. masa harina

In a small bowl or cup, put the mushrooms & bourbon; set aside to soak. In a large saucepan, heat oil over medium heat. Add shallots, garlic & serrano chile and saute till shallots are transparent, 2 to 3 minutes. Add venison and saute till evenly browned, stirring to break up meat, 10-15 minutes. Add chile powder and cumin and saute 2-3 minutes more. Add mushrooms and bourbon. Stir in beer, tomatoes, salt, pepper, and dried herbs. Bring to a boil, reduce heat and simmer briskly till thick but slightly liquid, about 1 hour. Sprinkle in masa, stir well and simmer until very thick, 5-10 minutes more. Serve over bean (black beans are good) or rice, with corn bread.

Accompany these dishes with family, friends and conversation to make the hunting experience complete.

Update on Dog Trialers Efforts regarding DNR Land Purchase

In the last issue of the newsletter we reprinted a news story from the Pioneer Press about the large tract of private property recently purchased by the Department of Natural Resources near Milaca, Minn. that might be turned into a dog-trialing facility.

The Minnesota Field Trial Association is the organization spearheading efforts by retriever people to work cooperatively with the DNR on this effort. The LLHRC has joined the MFTA in order to have a voice for hunting retrievers hopefully heard.

Vice President Jim Bowden has agreed to be our contact person with this group.

The following information comes from the MFTA web site.

MFTA is an organization of sportsmen with a strong interest in hunting, conservation, and especially the advancement of the pure-bred retriever breeds of dogs. The primary activity of the Association is to conduct AKC-member retriever field trials where the capabilities of the pure bred retriever can be demonstrated.

MFTA was formally organized in early 1937 and has functioned continuously since then as a member club of the American Kennel Club. The club became incorporated in April 1939. In the early years, there were no other field trial clubs in the state. In 1940 and every year until 1996, the Vestal Traveling trophy was awarded to the top Amateur handler in the Open stake. The trophy has now been retired and is on display in the Retriever Hall of Fame. MFTA held its field trials throughout the state, working not only to bring the capabilities of trained retrievers to the attention of the public but also to encourage the formation of additional retriever clubs in Minnesota.

MFTA's first trial was held in Winona, MN on May 21, 1938. From then until 1950 various locations served as trial sites - Winona, Mound, White Bear Lake, Rochester, Anoka, St. Cloud, Austin, Duluth, Bayport and Shakopee. From the fall of 1950 thirtythree trials were held at the James J. Hill North Oaks Farm (now the City of North Oaks). When the pressure of real estate development curtailed the use of the area, the Club moved to the Wild Wings of Oneka Game Farm and Shooting Preserve, near Hugo. From 1980 to 1984 MFTA held 10 trials on the Kelly Farms near Marine on St. Croix. From 1985 to 1988, the Club held its spring trials at Wild Wings and the fall trials at Kelly Farms. During a period of drought in 1989 and 1990, Kelly Farms was the site for both the spring and fall trials. Since 1991, MFTA has held its trials at the Benton Retriever Grounds, Inc.

From it's inception, MFTA has been characterized as a club whose members have been very active in both local and national competition while providing much of the leadership in the development of and continuing interest in field trialing. MFTA was one of the eleven charter club members in the formation of the National Retriever Club in 1941. Over the years, a number of members have served as Judges for the national championship trials put on by the National Retriever Club and the National Amateur Retriever Club. Recently a club member was inducted into the Retriever Hall of Fame. (An MFTA member was a primary driving force in the concept and organization of the National Amateur Retriever Club, and served as its first President.)

Dogs owned or handled by MFTA members have won at least nine Championships at the trials for the National Retriever Championship and/or the National Amateur Retriever Championship. Members have made their mark in Canada by winning the Canadian National Championships and Canadian National Amateur Championships.

SPOT IT/RUFFED GROUSE

Allison Campbell, St. Paul Pioneer Press, Published Feb 15, 2001, reprinted.

What: The chicken-like ruffed grouse lives mostly on the ground. But it can also fly acrobatically, hover and turn in the air as it weaves through its favored brushy forest habitat.

Minnesota has the most ruffed grouse of any state. The Department of Natural Resources, which has kept tabs on it for 51 years, notes the species currently is on the decline in its regular 10-year population cycle. Its numbers will probably continue to drop for the next few years.

Where: Camouflage plumage makes this bird tough to spot. But keep your eyes open, and you may see a ruffed grouse perched on surprisingly thin branches of birches, poplars or aspens as it feeds on catkins, buds or seeds. They live mainly in the central and northern parts of Minnesota and south of the Twin Cities, in counties adjacent to the Mississippi River.

What's up: A snowy winter is a boon for ruffed grouse, who establish a territory in the woods and do not migrate. The grouse can travel over deep snow with the help of extensions on their toes that act like snowshoes. Burrowing in the snow provides protection from predators and also helps to keep them warm.

How to Administer Pepto Bismol to Your Dog on the Advice of His Vet.

(as remembered by Dusty Fields in Lab Laffs, Online Retrievers, Vol X, No 5, Sept/Oct 99)

- 1. Check medicine cabinet for Pepto Bismol and discover the expiration date on your bottle is January 1996. Discard, look for purse and keys (15 minutes) and try to get dog into car.
- 2. Wait for dog to deposit 2 puddles of diarrhea on lawn and then decide not to take him in the car.
- 3. Get dog to go into house, knowing you'll be leaving him alone. Allow another 10 minutes for this.
- 4. Drive to the convenience store and pay \$2.59 for the smallest available bottle of Pepto Bismol. Buy yourself a double-chocolate "muffin" while you're there. You're gonna need chocolate before this is over.
- 5. Come home and make a big deal out of the fact that you've bought a special "treat" for your dog. With great ceremony, attempt to open the child-proof seal, and discover that it is also adult-proof. Slice off top of bottle with serrated knife before discovering how you should have opened the bottle. Duh.
- 6. Pour the recommended dosage (2 tbsp) into the provided cup and sit down next to your dog. Let him sniff the Pepto Bismol and then marvel at how fast he can run upstairs and cower in his crate. Allow another 15 minutes to get him downstairs to the kitchen where it will be easier to wipe up any drips that may occur.
- 7. Pry open your dog's Jaws of Steel and quickly unload the little cup of Pepto Bismol down his throat. Forget to clamp his mouth shut and witness pink liquid flying all over your kitchen.
- 8. Repeat Step #7, remembering to clamp dog's mouth shut. When you think he has swallowed the Pepto Bismol, release his jaws, and once again, watch the pink stuff fly all over him, the kitchen furniture and your pink t-shirt. Oh yeah, did I mention that wearing a pink t-shirt is advised here?
- 9. Repeat Step #7 (or 8, if you prefer) but this time do it on the patio.
- 10. Hose down the patio, and your dog, whose black, white and brown coat is now tinged with so much pink that he looks like he just came from a midnight showing of "Rocky Horror".
- 11. Wash down the entire kitchen . . . 30-60 minutes, depending on size of kitchen.
- 12. Go back into the house and call the vet. Make an appointment for that anti-spasmodic injection she suggested as a last resort. Consider asking spouse to take some time off work to bring the little angel to the vet because you've already missed 2 work deadlines because of this, and then remember that your spouse is spending this gloriously sunny and mild day . . . on the golf course.

President's Corner by Randy Gustafson Training Land – The "Big" Issue

Where in the Metro area can a person train their hunting retriever?

The backyard is fine for many activities, but it gets a bit dicey when you're working on steady to shot. Not every neighbor thinks nothing of the report of a 12 gauge firing poppers in the afternoon as your daughter, hidden from view behind the corner of the garage, throws frozen mallards in an arc across the lawn.

Setting up a 40 yard blind inside the city limits often involves the cooperation of more than one neighbor. The concept of busting through cover by tossing dummies over hedges as you take your daily walk doesn't build great neighborhood relations.

The majority of hunting dog owners living in urban and suburban areas are faced with a huge problem – where is there space to train your dog properly.

Training land and training water are critical to the success of our efforts. The LLHRC is very fortunate in that we have generous people like Al Freiberg and Jim Bowden willing to share their facilities and time so others can train. All dog clubs in our area are fortunate to have a resource like Kelley Farms available for holding Hunt Tests.

With the urbanization and suburbanization of more and more rural spaces how much longer will any training and testing grounds exist? Can affordable space for real training be found for the average sportsman?

How about public land? Minnesota has lots of public owned space – the question is whether there's space for the individual hunting retriever trainer that would work given the rules, regulations and related pressures that are ever present in "this state where nothing is allowed".

I read in the Feb 16th Outdoor News that the DNR is now facing the problem of how to handle the many smaller Wildlife Management Area (WMA) parcels that are being surrounded by housing subdivisions. These development locked wild areas that had been set aside and maintained for wildlife production and hunting are facing an uncertain future with ever continuing urban sprawl.

As the DNR and local governments start working on solutions to this problem perchance this is an opportunity for long term training grounds for hunting dogs across the state. Public input will most likely be sought.

If training spaces are to be available they must be discovered and held onto by treating them with respect. It is a challenge that all dog owners, hunters, sportsmen and sportswomen should be thinking about. And doing something about.
